


2024 Achievements of the Corporate Sustainable Development Committee

1. Sustainable Development Committee

M31 Technology's corporate sustainability initiatives are overseen by the Board of Directors. On December 27, 2022, the company established a cross-functional "Sustainable Development Committee," chaired by Chairman Huey-Ling Chen. The committee is responsible for formulating sustainability strategies and goals, leading various sustainability initiatives, and submitting annual plans for approval by the Board of Directors.





On August 6, 2024, the Board of Directors adopted the Organizational Charter of the Sustainable Development Committee and appointed Chairperson Huey-Ling Chen, along with four directors, to form the Committee. Authorized by the Board, the Committee is responsible for formulating, promoting, and strengthening the company's sustainability policies, annual plans, and strategies.

The Sustainable Development Committee oversees an implementation unit and four working groups (originally formed as cross-departmental teams). Each working group is responsible for implementing the Board-approved annual sustainability plan, conducting quarterly reviews, tracking progress, and compiling the ESG report to ensure transparency and accountability in the company's sustainability performance.
